

### Misdemeanor Bond Schedules:

Note: Municipal court not of record cannot exceed \$500 for criminal offenses, except drug and alcohol related offenses and then the municipal court not of record can impose a fine up to \$800 under the new laws. Traffic offenses cannot exceed \$200, or exceed the fine amount prescribed under the state statutes. All other moving traffic offenses not listed, the fine will be \$100. A court cost of \$60 plus \$19 for CLEET/AFFITS, (\$79 total court cost), will be added to the cost of all fines paid. On all Municipal offenses, as long as they are not contested, do not have to appear before the municipal Judge of the City of Cache provided the payment is made in full. Per approval of the municipal Judge, a payment plan may be established for those that wish to make payments to the City of Cache, (up to 3 months for up to \$400 and up to 6 months over \$600). A third of the fine amount needs paid up to \$400 and one forth paid up to \$600, if at all possible at the time of court.
