AN ORDINANCE OF THE CITY OF CACHE, OKLAHOMA, AMENDING CHAPTER 11, ARTICLE 2, SECTION 11-16 BY REPEALING PARAGRAPH 1; ADDING A NEW PARAGRAPH 1; PROVIDING FOR A NEW MUNICIPAL COURT FINE SCHEDULE; INCREASE IN THE FINE ASSESSMENT FEES; AND DECLARING AN EMERGENCY.

WHERES, the City Council recognizes the need to adopt new Municipal Court Fine schedule in accordance with Title 22, Section 1115.3(E), of the Oklahoma Statutes, and has determined it to be in the best interest of the citizens.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Cache, Oklahoma:

SECTION 1: From and after the effective date, Paragraph 1 of section 11-16, Article 2, Chapter 11 of The Cache City Ordinances shell be repealed.

SECTION 2: From and after the effective date, Paragraph 1 of Section11-16 Article 2, Chapter of the Cache City Code of ordinances shall be added and adopted to read as follows:

§ 11-16 MUNICIPAL COURT FINES.

1. The following schedule of fines is hereby established:
